The latest update of ITC has a new feature for Vision agents. This feature allows the Turbo Rater to retrieve the wholesale ACV for the vehicle that is entered. This new feature will allow faster rating of physical damage coverage. Please be sure to update your ITC Turbo Rater and make sure that the new feature is installed when you are rating. The ACV section of the rater should have a new box that should be labeled ACVW (see picture on right). New Endorsement Feature on Vision Insuror-Atlas Web

The Vision Insuror-Atlas Web site has a new endorsement feature for monthly policies. The “Payment with Endorsement” button (shown to the right) is designed for *lapsed* monthly policies that need an endorsement processed as a monthly payment is received. Below are the steps for this endorsement feature:

1. Click on the “Payment w/ Endt” button
2. Complete the change on the rating menu
3. Click on the “Rate” button for the new rate
4. Complete the endorsement notes.
5. Click on the “Process Renewal” button
6. Enter the new payment amount that is required
7. Click on “Issue Renewal” to receive a copy of the new ID cards and dec page
